CIVIL SERVICES (MAIN) EXAMINATION, 2021

Date: 10-10-2022

The result of the Civil Services (Main) Examination, 2021 was declared vide Press Note dated 30.05.2022 recommending 685 candidates in order of merit for appointment to IAS, IFS, IPS and Central Services Group 'A' and Group 'B' against 749 vacancies.

2. The Commission, in accordance with the Rule 20 (4) & (5) of the Civil Services Examination Rules, was also maintaining a Consolidated Reserve List in order of merit below the last recommended candidate under the respective categories.

3. As sought by the Department of Personnel & Training, the Commission has now recommended 63 candidates which include 46 General, 12 OBC, 04 EWS and 01 SC, to fill up the remaining posts based on the Civil Services Examination, 2021. Particulars of these candidates are included herewith. The candidates so recommended will be intimated directly by the DOP&T.

4. The candidature of 03 (three) candidates bearing Roll No. 0513127, 0823523 and 6628870 are provisional.
