Moreover, the private schools have formed a sort of cartel and in the last few years, pushing for ever increasing fee hikes. There is discontent in parents against the steep rise in fees over the last few years.

With the onset of covid-19 pandemic, most schools have transitioned to the online mode of classes, while school fees have also been increased in line with the trend of past years. This has led to a strong protest by parents as they feel that the fee hike is unjustified owing to no physical classes, reduced maintenance cost for schools and very high fee already being charged by these schools. Parents have started an organised protest against the private schools of the state. There is also anger among the parents against the state government as the parents feel that the issue has not been dealt with required seriousness by the government. The parents have, in the past, submitted various representations to the government giving details of the entire issue through multiple authorities in the government. However, no action has been taken on any of their previous representations. The schools on the other hand argue that the facilities provided by them are world class and that they have made substantial investments in digital infrastructure for online mode of teaching. They also justify the fees in terms of salaries for high quality teachers and for not compromising on the overall quality of education despite the challenging demands of the pandemic.

The issue has also been used by opposition parties to corner the government as some of the private schools are owned by certain corporates who are known for their close ties with the ruling party. News channels are also covering the issue extensively and it has become headline in most of the channels further putting pressure on the government to resolve the issue at the earliest.

The parents are of the view that there is nexus between government and private schools. Even after repeated representations, government has not come out with clear guidelines and the prevailing ambiguity favours the private schools. Parents are demanding that the recent fee hike should be rolled back otherwise they would launch a larger protest.

The government has constituted a committee to deliberate on the issue and submit a report to the Government. The committee is also assigned the role of interlocutor between parents and schools and asked to mediate so that the issues are addressed amicably.





Vishing fraudsters often use modern VOIP (Voice over Internet Protocol) features such as caller ID spoofing and automated systems (IVR) to impede detection by law enforcement agencies. Voice phishing is typically used to steal credit card numbers or other information used in identity theft schemes from individuals.

The police received information about a brothel being operated in one of the hotels of the city. Police raided the hotel and found around twenty girls there, most of them being below eighteen years who were forced into prostitution. All the girls were sent for medical test in the district hospital. It was found that one of the girls who is a minor is eighteen weeks pregnant and she is also HIV positive.

Police booked the owner of the hotel and sealed the premises. A lookout notice was published for all the others involved in the sex racket. Also, an FIR was filed implicating the owner of the hotel and others involved. Since majority of the girls were minor and they were unable to give exact details about their parents, the rescued girls were sent to the care of an NGO for the time being. When the warden of the hostel informed the minor girl about her pregnancy and HIV status, the girl stated that it was the result of forceful sex and she wants to terminate it. The process for termination of pregnancy for rape victims is time consuming as it is necessary to bring along the FIR, and for teenage victim complaint under POCSO act is also needed. It is notable that aborting a foetus is very difficult after it is twenty-four weeks old. In trying to comply with the requirements, the pregnancy of the minor girl has grown beyond the 24-week stage.

With the help of the NGO, the girl submitted an application to the state authorities stating that "the child was conceived due to forceful and undesired sexual intercourse against her will that amounts to rape and she wants to terminate the pregnancy". Her repeated requests to terminate the pregnancy have been turned down by the state authorities as after 24 weeks it is very difficult to get a foetus aborted. Indian law permits terminations after 24 weeks only on advice of a medical board under the condition that the pregnant woman's life is in danger or the foetus has substantial abnormality.

पुलिस को सूचना मिली थी कि शहर के एक होटल में वेश्यालय चल रहा है. पुलिस ने होटल में छापा मारा और वहां लगभग बीस लड़कियां मिलीं, जिनमें से ज्यादातर अठारह साल से कम उम्र की थीं, जिन्हें वेश्यावृत्ति में मजबूर किया गया था। सभी बिच्चियों को जिला अस्पताल में मेडिकल परीक्षण के लिए भेजा गया है. यह पाया गया कि नाबालिंग लड़कियों में से एक अठारह सप्ताह की गर्भवती है और वह भी एचआईवी पॉजिटिव है।

पुलिस ने होटल के मालिक के खिलाफ मामला दर्ज कर परिसर को सील कर दिया है। सेक्स रैकेंट में शामिल अन्य सभी लोगों के लिए लुकआउट नोटिस प्रकाशित किया गया था। साथ ही होटल के मालिक और इसमें शामिल अन्य लोगों के खिलाफ प्राथमिकी दर्ज की गई थीं। चूंकि अधिकांश लड़िकयां नाबालिग थीं और वे अपने अभिभावकों के बारे में सटीक विवरण देने में असमर्थ थीं, इसलिए बचाई गई लड़िकयों को फिलहाल एक गैर सरकारी संगठन की देखरेख में भेज दिया गया। जब छात्रावास के वार्डन ने नाबालिग लड़िक को उसकी गर्भावस्था और एचआईवी स्थित के बारे में सूचित किया, तो लड़िकी ने कहा कि यह जबरन सेक्स का परिणाम है और वह इसे समाप्त करना चाहती है। बलात्कार पीड़ितों के लिए गर्भावस्था को समाप्त करने की प्रक्रिया में समय लगता है क्योंकि प्राथमिकी साथ लाना आवश्यक है, और किशोर पीड़िता के लिए च्वेट अधिनियम के तहत शिकायत की भी आवश्यकता है। यह उल्लेखनीय है कि चौबीस सप्ताह का होने के बाद भ्रूण का गर्भपात करना बहुत मुश्किल होता है। आवश्यकताओं का पालन करने की कोशिश में, नाबालिग लड़की की गर्भावस्था 24 सप्ताह के चरण से आगे बढ़ गई है।

Q.12) The farmer unions in one of the states has called for mass protest owing to large number of arrears/their dues not being paid by the private sugar factories for the last two years. On the day of mass protest, farmers turned up in huge numbers and at several places the protest turned violent. There were instances of stone pelting, vehicle burning etc. The police were not able to control the violent protesters at some places and had to resort to lathi charge. But at one of the places, police resorted to firing in which four farmers were killed. This further aggravated the situation as farmers at other places also resorted to violence to protest against police action.

Looking at the intensity of the situation, under opposition pressure, one of the Minister of the state gave the statement that farmers did not die due to police firing but there were some anti-social elements amongst the protesters who fired in order to create unrest in the state.

This statement of the Minister instead of calming the protesters further angered them as some eyewitness testified to news channels about the deaths being the result of police firing. All this further projected government in bad light and the police action has come under severe criticism by various sections of intelligentsia. The public sentiment has started to sway in favour of the protesting farmers.

There is huge pressure on the government to diffuse the tension, address farmers' grievances and take action against the police personnel involved in firing at the protesters since the protesters have started blocking all the major state highways which has crippled the day-to-day routine of the people of the state. Further, there is danger that the situation may get out of control anytime.

Suppose you are the district magistrate where the incident has taken place;
