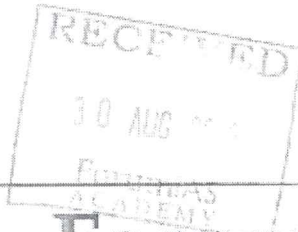

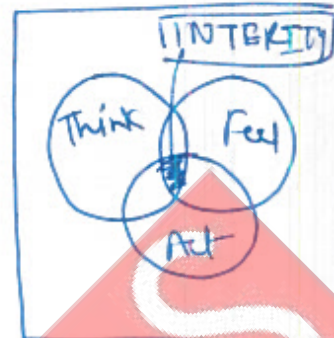
FOUNDATIONAL VALUES in civil services refers to those values and principles which forms the very basis or essence of services. These are absolutely must for a civil servant to pursue at all times.

Eg. Integrity, honesty, impartiality.

They are said foundational because they form the base of civil services on which other duties and functions rest. If pursued these values, public functioning can provide best of services and work in public interest. These values insure dedication to work, work objectivity and hence larger public interest is served.

Two values of paramount importance :

① INTEGRITY : it refers to thinking, feeling and acting in same direction, uncompromised, indomitable will to stay true and to upright.



(eg: T.N. Meshram, former FCI was a man of integrity who ensured electoral reforms even in presence of political pressure.

② DEDICATION TO SERVICE - it leads to sole emphasis on service and its objectives and helps in sidelining private interests. It helps a civil servant to be ready to take challenges, stay strong & committed in tough times. (eg: Prashant Nair, Kerala cadre IAS officer ensured proper flood relief even in toughest situations.

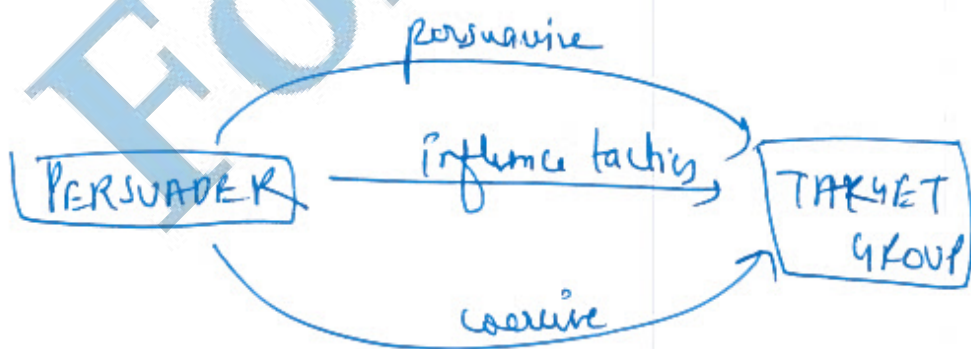

Social influence and persuasion refers to moulding the behaviour of Target Group in intended direction, both individually or socially.

Beti Bachao Beti Padhao, scheme was launched in Haryana in 2015 by PM Modi with an intention of increasing sex ratio which was then : 811/1000 mds. To curb the practice of female foeticide, this scheme was launched.

Aristotle and Plato :

- ① Temperance
- ② Wisdom
- ③ Courage
- ④ Justice

Eg: Mahatma Gandhi applied virtue ethics throughout his life. In South Africa he fought against inequality & ~~in~~ and showed courage and urge of justice. Also in Indian National Movement, he used non violence and showed integrity by calling off NCM due to dharti dhara incident.

CIVIL SERVANT → Civil services today has evolved in a complex ~~services~~ service which deals with diverse people at all times. Therefore,

highest order values are required to fulfill the principles of civil services.

① Civil servant can show courage in day to day challenges and even in most demanding situations. (Eg): Flood evacuation, bringing out corrupt practice of own department etc.

② Can evoke his full wisdom in solving problem of all the citizens and show compassion & empathy.

③ Also Using Justice approach to he/she can ensure rule of law and democratic experience.

④ Therefore, civil services in order to evoke to highest order public services must evince virtue ethics.

EGOISM**

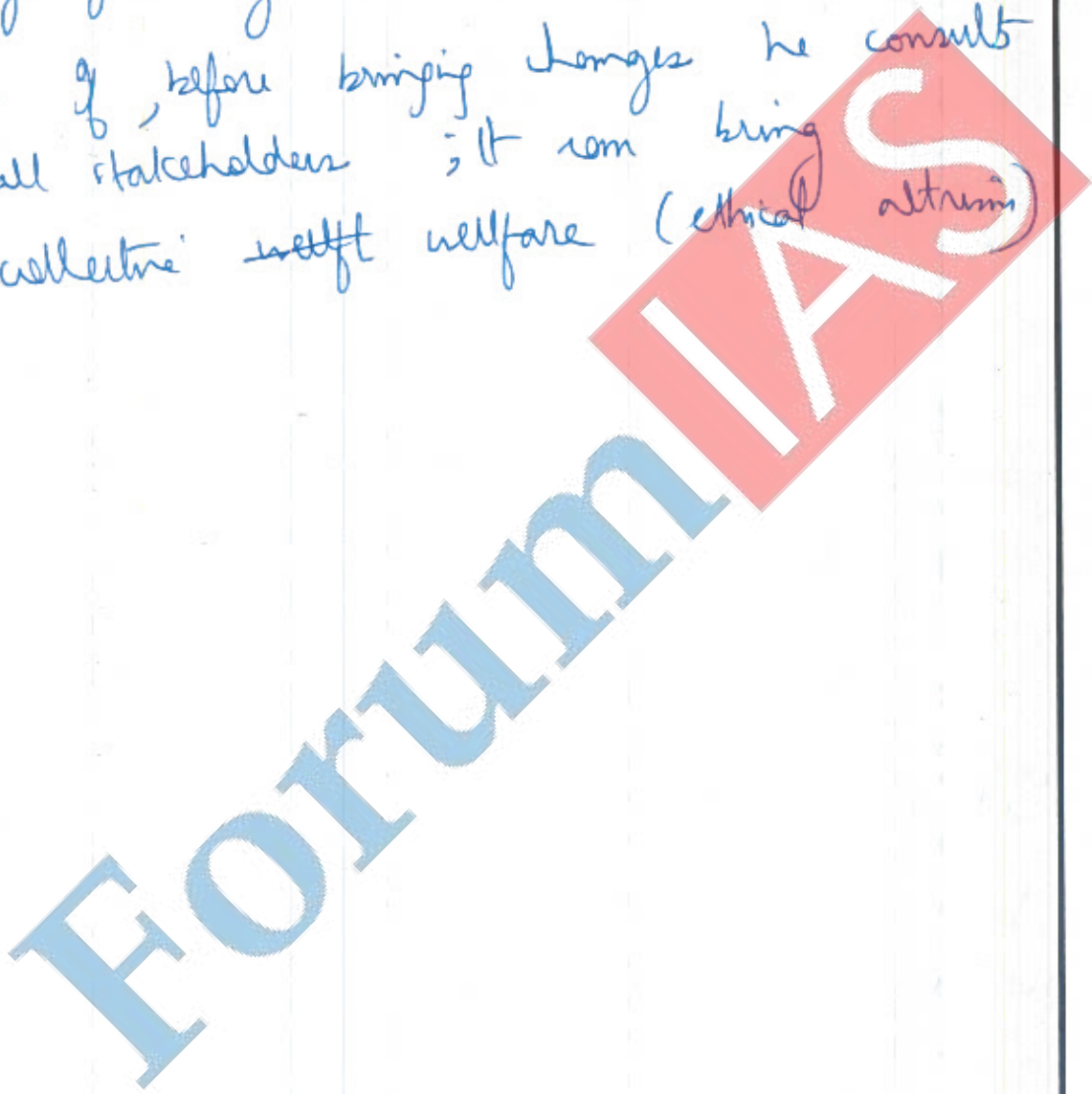
- consequences which are more favorable than unfavorable to the "doer of action of only."

Eg: Rajkom Mohan Roy's altruistic desire to uplift the status of women was both rational, objective & also empathetic.

Eg: Having empathy towards one's group which is involved in terror activities is irrational & non-objective.

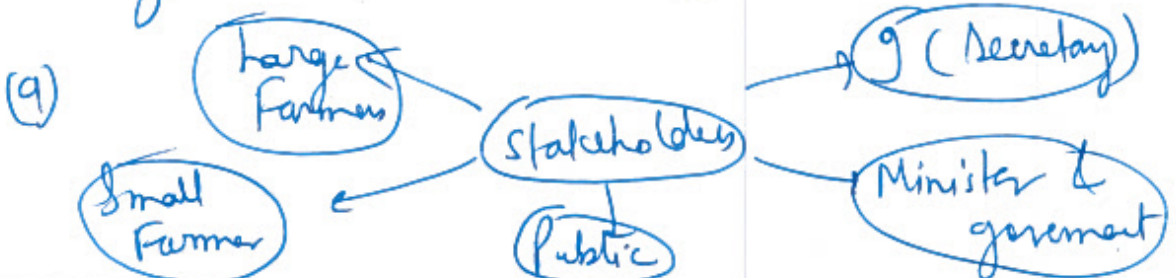

Q.7) You are a Secretary in the Ministry of Agriculture. Your Minister has proposed a fixed annual grant to farmers which is expected to cost the public exchequer heavily. Having already taken the decision, he asks you to come up with a research to support the scheme. After a lot of effort, you find that socio-economic benefit of the scheme is reaching only large farmers due to many intricacies in the selection of beneficiaries. You approach the Minister with relevant facts and ask him to plug the gaps in the proposed scheme, so that small and marginal farmers can benefit from this decision. However, he asks you to suppress the drawbacks, and actively promote the scheme through mass media as the electoral benefits are more important than socio-economic impacts. Elections are due in less than 3 months and the political party currently in power is expected to return back with a majority. Your promotion is also due around the same time. As a secretary you are expected to fully support and cooperate in the ministers' decision, and make the scheme a success, despite all the drawbacks in the scheme.

- Mention the different stakeholders in the above situation and also highlight their prospective interests.
- What are the ethical dilemmas faced by you in this situation?
- Some of the alternatives for you to handle the situation could be:
 - Follow the commands of the Minister.
 - Insist on the publication of results and let the public decide whether it wants the scheme.
 - Call a press conference and brief the media about the results and the callous attitude of the Minister.

Suggest any other possible option(s). Evaluate all of them and suggest the best course of action, giving reasons for it. (20 Marks, 250 Words)

In the above case I, Secretary of Min. of Agriculture, have been given task of actively promoting an annual grant scheme to farmers by the Minister. However, the scheme is only benefiting large farmers and also causing huge cost to public exchequer. In this case, I have to give the best way possible.

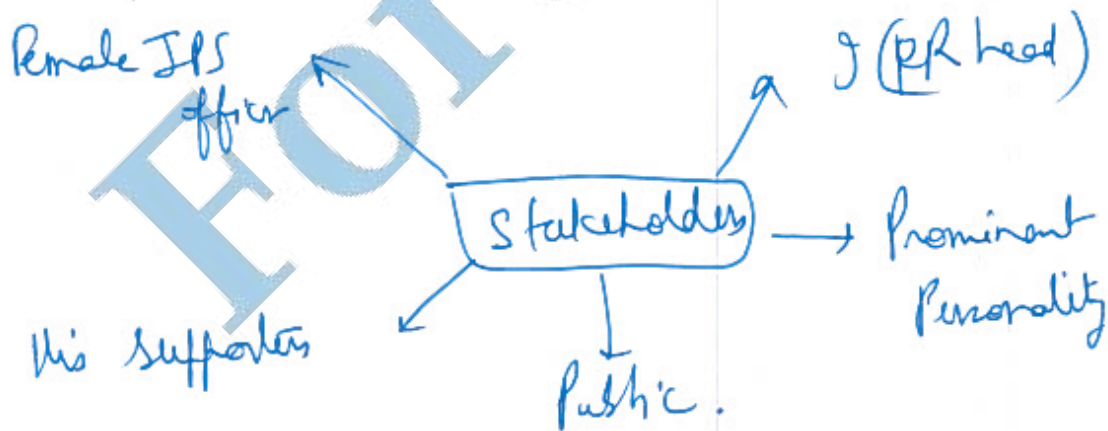

a) Indicate the values at conflict in this case.

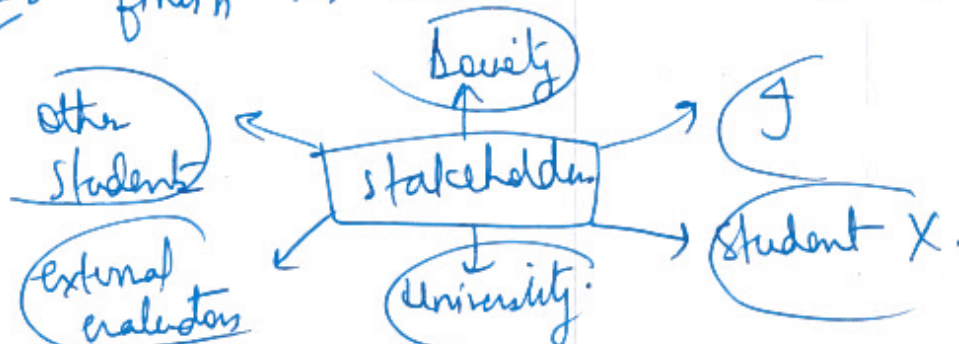
b) Consider these options.

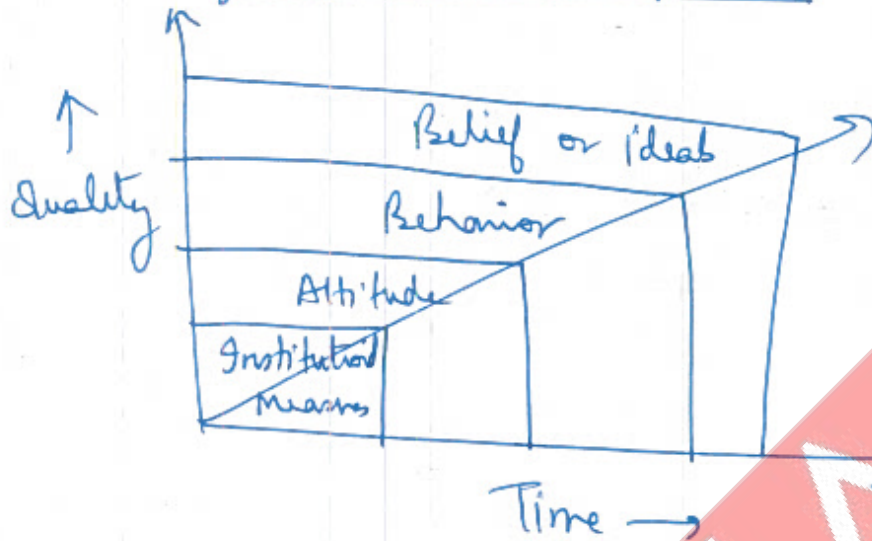

Q.11) There is a reported incident of brutal attack on doctor at a Medical College and Hospital after the death of a septuagenarian patient. It triggered to shutdown of healthcare services in medical colleges across the city as a mark of protest.
