 - ④ Gandhiji's Talcimen which talks about poor and deprived draws heavily from this philosophy.
- The Utilization approach is one of most important ethical principles for good governance.

Emotional Intelligence, is the branch of behavioral studies which deals with studying, analyzing and directing and channelling human emotions for a productive usage.

Daniel Goleman popularised the concept of EI. He was one of the prominent proponents who said

" EQ (Emotional Quotient) is more important than IQ."

Emotions reflects the extraordinary state where normal sense of reasoning, logic and thinking are influenced highly.

e.g. Anger, pleasure, Grief, Tension all these hampers our decision making.

EI is about -

- ① Self Awareness
- ② Self Control
- ③ Social awareness

The understanding of EI helps to be aware of one's emotions which would direct and control it to be self managed (NOT to be excessive/aggressive or submissive)

Social awareness in EI helps to know about surrounding and the society and the social management helps to control the behaviors.

EI helps a person to be within the limits and helps him/her to channelize his emotions for a betterment of his life. It encourages positive thinking and rationality.

- b) Examine the relevance of the philosophy of Integral Humanism given by Pandit Deendayal Upadhyaya in contemporary Indian society. (10 marks)

Integral humanism was the idea of Pandit Deendayal Upadhyaya which was largely based on ancient Indian philosophy of Advaita and Buddhism. He wanted India to follow the middle path and shunned the idea of capitalism as well as socialism.

The relevance of Philosophy in current Indian society are :-

- ① He said the 4 purusharthas (Karma, Artha, Dharma, Moksha) needs to be followed, only following Artha would not lead to Moksha.
It shows the importance of holistic development rather than a singularistic view of profit-making.

a) "Compassion and tolerance are not a sign of weakness, but a sign of strength" - Dalai Lama.

Compassion is a quality of feeling others pain and thinking of ways to alleviate the pain.

Tolerance is the quality which has values of respecting (and withholding) the pain. (Pain may be because of self or because of others).

Both these qualities are high order virtues and needs to be followed by all; though it is not easy for everyone to have these qualities.

The relevance in present context -

⇒ At societal level

↳ Problem of lynchings and attack on rational thinking.

Compassion and Tolerance by majority over the minority would make them safer and majority can show the sign of strength and resilience.

At political level

↳ The dominant ruling party needs to take up the views of opposition also, so that there is quality decision making.

At environmental level

— The richer and developed countries need to understand and tolerate the requirements of developing countries.

Compassion and tolerance is required by the majority people and by the minorities who might feel threatened with minority view, but if they are able to show the above 2 qualities, the position of strength is displayed and they need not worry about their position of strength.

Q.7) You are the administrative head of a department in an important urban area. As the administrative head, you have the duty as well as the responsibility to implement all the laws formulated by the legislature, directives given by your seniors and the court of law. You are known to be an upright, disciplined and compassionate person. You aim to alleviate the pain and suffering of the poor and destitute. ✓
The area under your jurisdiction has seen a rampant proliferation of illegal slums, especially throughout the railway lines and industrial zones. The urban area has witnessed a huge influx of immigrants as it provides numerous employment and livelihood opportunities for the youths residing in nearby villages. Most of them are tribal, who have migrated to overcome poverty, hunger and starvation. ✓
These slums have become home to many low paid workers for nearby factories as well as cheap vendors of groceries and essential commodities to the middle-class urban households in the area. However, these slums have also become a hotspot for many water-borne and communicable diseases due to poor sanitation and hygiene and healthcare facilities. The area has also become a breeding ground for many criminal activities and hideouts for criminal due to difficulties in law enforcement. ✓
For a long time, the government has been mulling on the idea of revamping and beautification of this place. A PIL was filed against these unauthorized slums and the court has ordered for the destruction of all the illegal encroachments on public land. However, this year the present monsoon year has witnessed unprecedented rainfall and most of the areas have been inundated.

The seniors of your department have been pressurizing you to remove the encroachments by force, even when the situation is not congenial. The court has also asked the administration to file a progress report on the courts order. Being the enforcing officer in such a situation, consider the following questions, ✓

- Bring out the ethical issues involved in the case.
- Evaluate the merits and demerits of various options available to you.
- What would be your course of action? Justify your answer!

The above case is about illegal encroachment of land by poor people to develop slums and the failing administrative and legal need for removal of these slums.
The challenge is compounded by monsoon which has

(A) Ethical issues involved in case are:-

- ② Livelihood vs Joblessness and distribution of poor.
- ③ Legal orders of court vs illegal settlement.

- ⑤ Bureaucratic apathy vs judicial activism.
- ⑥ Right to shelter vs Health of others.

(B) Various options available to me

Q.8) Social media platforms have created great convenience for our societies by expanding and diversifying the ways people communicate with one another, and yet these platforms have the power to cause harm like sending hurtful messages to a person in form of harassment known as cyberbullying. Some acts of cyberbullying might not only be considered defamatory, but also cause serious consequences.

Madhav, a 55-year-old manager at a shopping store in Gujarat, has recently been a victim of cyber harassment. After discovering that a 19-year-old female employee posted an abusive post about Madhav, making derogatory comments about his character. Madhav confronted the girl during an official meeting and asked why the girl posted such hurtful comments that could harm the manager's reputation, the girl meekly replied that she was upset at the time. The manager responded that he was very upset by the girl's actions. Demanding a public apology in front of all the staff, Madhav stated that he would not allow "young brats" to call him those names. Madhav uploaded a video of this confrontation online, attracting lots of attention.

While Madhav was subjected to cyber harassment, some felt he went too far by confronting the girl in-front of everyone during a meeting and posting the video for the public to see, raising concerns over the privacy and rights of the girl. Seema Chhabra, who writes a column for a leading newspaper, notes, "We do need to remain benevolent and understanding towards teens when they demonstrate immaturity." Confronting instances of a teenager venting her anger may infringe upon her basic rights to freedom of speech and expression. Yet, as Chhabra explains, Manager and girl were both perpetrators and victims of cyber harassment. All the concerns of both parties must be considered and, as She wrote, "The worth of one's dignity should not be on a sliding scale depending on how old you are."

- a) In trying to teach the girl a lesson about taking responsibility for her actions, did the manager go too far and become a bully?
- b) According to you, who is the victim in this case? Was one more victimized than the other? Explain.
- c) Do you think factors like age and gender used to "excuse" unethical behavior in our society? Justify with examples. (20 marks)

(a) The manager did the "tit for tat", but it was not right as per me. It is said that an eye for eye will make the whole

Context- the manager should have thought other ways like - taking full influence of in full - using the company's code of conduct or even asked for independent enquiry to know about her governance and addressing them.

By doing the same thing what - the girl did to him, violated the principle of natural justice and the girl would not get reformed, rather this may lead to a cycle of hate. Yes, the manager went too far ahead and bullied her.

(b) According to me, the girl here has become the victim of cyber bullying as well as her privacy and fundamental rights were violated.

No doubt Madhav was a victim of the girl's immaturity and rash of mind. She could have

sought other methods to vent out his grievance, but he treaded on the dangerous path for mob justice and ~~social~~ media trial which in itself is biased, unfair and unethical.

But Madaan made a bigger mistake by posting the confrontation online.

"To maintain a fault known is called as double fault". Here, Madaan again committed the same mistake of which he was accusing the girl of. Hence, in my opinion the girl is more victim than others party (Madaan) considering the issues mentioned above.

- ① Yes, in our society there is biasness to our decision making with respect to factors like Age and sex.

In our laws also there is special exemption to age (Juvenile) and some respite to women

In the very first week of work, you have been informed that the wedding ceremony of a 24-year-old man from religious community A and a 19-year-old woman from religious community B was stopped by some unknown groups, which was to be solemnized as per the ritual of Community A, a majority community in the district. Although the marriage had the consent of the couple, the families on both sides are against this interfaith marriage and had filed complaints with the police separately. Under the new law passed by the state government, official permission of the SP is mandatory for interfaith marriages. The police, who were acting on complaint, asked the couple to seek your nod for their marriage. ✓ The couple approached you seeking permission and support to the marriage. They informed you that the vigilante group has threatened them against the marriage with serious consequences and also tried to harass the woman. The couple was reluctant to file any charges against the incident due to fear of life from their families and vigilante groups.

On probing the matter, you found that in one of the panchayats, ration continues to be procured in the name of 318 people who are dead and this practice is prevalent all over the district. ✓

When you investigate the matter, some beneficiaries from a particular village said that it was not their fault as the authorities have not removed the deceased persons' names from the ration cards. They also argued that the ration received is very helpful to the family members including kids of the deceased people. According to them, while giving away such a small quantity of food wouldn't make much difference to the government, it can bring a significant change in the lives to those benefitting from it. ✓

Further, the inquiry revealed that the local politicians are in nexus with the PDS suppliers with definite profiteering out of the ghost beneficiaries. Both of these stakeholders have colluded with local authorities to bypass the established procedures.

Q.11) As drum thumps and thousands of people cheer, several men jump on the backs of the bull and try to hang on as it jumps and fights aggressively. Such adventurers win prizes as utensils, clothes, bicycles, motorbikes or even a car if they hold on to the bull for three jumps in 30 seconds. ✓

These are scenes from a very popular bullfighting festival which takes place across a state during the annual harvest festival. Bullfighting has had its roots in rituals and culture of the state, dating back many centuries. To the people, the spectacle of bullfights is not a mere sport. The event is not only culturally significant, but also considered a fine art in which the bullfighter is trained in a certain style and elicits emotion through the act of the fight. ✓

However, despite its cultural importance, bullfighting continues to face increasing scrutiny from animal rights activists as it is considered to cause pain and suffering for animals as well as humans. According to media reports, so far 71 people have been injured this year alone in a single district. Many graphic images of animal torture have also been circulating on social media, making the issue catch attention of the national and international media.

A columnist, in his article, defends the practice and circumstances of the bull, "In terms of animal welfare, the fighting bull lives four to six years whereas the meat cow lives one to two. 

Q.12) Amrita is a 19-year-old student in a prestigious college in the national capital. She has been a bright student throughout her academic career and has a promising career ahead. She hails from a lower middle-class family with limited financial resources. She has been vocal about many issues facing the society and environment in the recent past. Citing her activism, she was even awarded the "Young Climate Activist" award by a well-known international Non-governmental Organization.

Recently, farmers of the country expressed their anger and frustration against the government for a farm legislation by organizing a large-scale protest involving thousands of farmers. The protest continued for many months peacefully but failed to produce an amicable solution. So, the farmers decided to intensify their protest by breaching the city barriers and organizing a "tractor rally" in the national capital. Amrita also took to social media to express her support for the rally. She expressed her outrage against the government policies and pleaded support from the general public and international media.

The rally was to be done peacefully, in consultation with the police, however, it got out of control and became violent. There were instances of violence against police personnel and civilians along with defacing of many monuments of national importance. An enquiry into the matter was therefore ordered.

During the probe, the investigation agency found that the violent events were not spontaneous but carefully planned and orchestrated by external separatist forces including some terrorist organizations. They also found that many Indians helped these forces by sharing and promoting their agenda on social media platforms through documents containing plans of the disruption. Among others, Amrita was also found to be guilty of being an accomplice to the conspiracy to cause violence during the protest.

An FIR containing charges of sedition and conspiracy with secessionist forces was filed against Amrita. The police detained Amrita and reported that many digital records and incriminating evidence were found against her.

Amrita's case gained traction in the mainstream and social media. While some felt she was just a kid who was expressing her opinion as was her right to do so, others felt that she was colluding with secessionist forces and must be punished according to the law.
