SITUATION SPECIFIC QUESTIONS:

- 1) You are DM of a district with a sensitive international border.
- 2) A tribal community refuses to allow construction of a military radar station on a hill they consider sacred. The Army argues the radar is critical for national security.
 - a) How will you resolve this while respecting cultural rights?
 - b) What anthropological tools will you use to understand their worldview?
- 3) A Particularly Vulnerable Tribal Group (PVTG) in your district speaks a language that only 300 people know.
 - a) Government schemes rely on digital apps available only in Hindi and English.
 - b) How will you ensure service delivery without accelerating language extinction?
- 4) A tribal community practises a coming-of-age ritual where children spend 48 hours in forest isolation.
- 5) After a recent leopard attack, the community refuses to suspend the practice, saying "Our ancestors watch over the children."
- 6) As DM, what approach will you take?
- 7) How will you negotiate without cultural imposition?
- 8) Two tribal communities with different mytho-historical claims over the same forest patch clash violently.
 - a) Both claim ancestral rights under the Forest Rights Act.
- 9) How will you investigate and mediate, using anthropological insights into lineage, territory, and oral history?
- 10) Labourers find ancient pottery and tools near a construction site. Archaeologists believe the site might be a major cultural discovery.
- 11) Local villagers demand the road must continue as it connects them to a hospital.
- 12) How will you balance development needs with cultural heritage conservation?
- 13) A district receives multiple petitions from castes claiming ST or OBC status.
- 14) A political leader suggests using "genetic similarity testing" to determine eligibility.
- 15) How will you respond?
- 16) How will you explain the anthropological limitations of genetic ancestry in administrative decisions?
- 17) A tribal settlement refuses polio vaccination, saying the village healer's ritual protects children from disease.
- 18) A polio case is reported in a nearby district.
- 19) How will you design a culturally sensitive immunization strategy?
- 20) Whom will you engage as cultural brokers?
- 21) A development project requires relocating a tribal village from a forest area. They refuse, saying the forest is their "mother" and relocation will "break their spirit."
- 22) What steps will you take to evaluate their cosmology, livelihood systems, and the symbolic value of land before proposing alternatives?
- 23) The Ministry proposes installing drones to monitor illegal mining in a forest region.
- 24) The tribal council opposes it, calling it "the sky-spirit watching us."
- 25) How will you negotiate between environmental protection and cultural interpretations of technology?
- 26) A few families convert to a new religion.
- 27) The larger community accuses them of "destroying tradition" and boycotts them socially.
- 28) How will you apply anthropological concepts of identity, acculturation, and social cohesion to defuse tensions?
- 29) You are drafting a climate resilience plan for a major city.
- 30) An expert tells you to integrate indigenous knowledge systems into urban planning.



- 31) Which anthropological methods will you use to identify, validate, and incorporate such knowledge meaningfully?
- 32) An AI-based welfare delivery system is introduced in your district.
- 33) It consistently marks nomadic tribes as "missing" because they lack fixed addresses.
- 34) How will you identify the cultural bias in the system and redesign it with anthropological sensitivity?
- 35) A tribal council excludes women from decision-making, calling it "ancestral rule."
- 36) But women complain that decisions about forest produce directly affect them.
- 37) How will you facilitate inclusion without imposing external norms?
- 38) During a disease outbreak, migrant workers from different tribal and caste backgrounds do not trust each other.
- 39) Quarantine centres become sites of conflict.
- 40) How will you apply anthropological understanding of inter-group relations to design a conflict-free, culturally sensitive quarantine system?
- 41) In a rapidly digitalizing world, is ethnography losing its relevance? Or will alternate forms of writing ethnography begin? Highlight.
- 42) The concept of "tribes" is a colonial construct. Can the notion of "tribe" still be anthropologically defended in contemporary India? Why or why not?
- 43) Imagine a district where tribals oppose a government hydropower project citing 'ancestral connections to the land'. How will you reconcile development and cultural continuity?
- 44) Why do well-designed schemes fail in marginalized communities? Analyse using anthropological perspectives.
